

## **PRIVACY POLICY**

Protecting your private information is our priority. This Statement of Privacy applies to andieraycompany.com, and Andie Ray Company and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Andie Ray Company include andieraycompany.com. The Andie Ray Company website is an information site. ### **COLLECTION OF YOUR PERSONAL INFORMATION**

In order to better provide you with products and services offered, Andie Ray Company may collect personally identifiable information, such as your:
